ABOUT VCAT FEES

VCAT fees are charged according to three levels:

- · corporate fees for businesses and companies with a turnover of more than \$200,000 in the previous financial year, corporate entities and government agencies
- · standard fees for individuals, not-for-profit organisations, and small businesses and companies with a turnover of less than \$200,000 in the previous financial year. Companies must provide a statutory declaration to support this claim
- · concession fees for people who hold the Australian Government Health Care Card. You must provide a copy of your card with your application.
